HALBERTON VILLAGE HALL RISK ASSESSMENT – 2ND August 2022







This risk assessment follows the advice given by the HSE for small organisations.

The Trustees decided to do a risk assessment of Halberton Village Hall to control the risks to people who used the hall and were involved in its maintenance and upkeep.

To identify the hazards the Trustees decided to:

- Looked at HSE's web pages for free health and safety advice and guidance for small businesses;
 - Walked around the Hall, car park and other areas noting things that might pose a risk; and
- Spoke to other users of the Hall to learn from their experience and to get their views on health and safety.

The Trustees discussed the findings. They decided to put in place the risk controls identified. The risk assessment would published on our web site www.halbertonvillagehall.org to be available to all users of the Hall. The Trustees decided to review the risk assessment regularly, or immediately if any changes occurred to the Hall or how the Hall was used.
